These residents are a joy (most of the time). What a hoot to watch them participate in Special Olympics,


daily work, as well as plant sagebrush with the BLM. Lisa and I have fed every house a special dinner and have done weekend relief in our Columbus home.

In the vocational area of Special K Ranch, we strive to provide challenging yet achievable results for improving our resident's knowledge, skills and/or behaviors. In the behavioral area, that can mean we help them gain confidence in themselves and their abilities and expand their grasp on being better human beings. Sometimes though, it can be a challenge for us to convince a resident to try something new in the vocational area, when we know they have chosen to believe in a falsehood about the area we want

to introduce to them. A new area is often something they have never done before. I want to give you a shortened look at two residents who were good at doing the work in the ranching and livestock area, but I wanted to challenge these two capable guys to try out our Greenhouse program and see if there would be something that they could learn and be good at.

At first it was a big struggle because these two guys thought that they were the only residents that could do the livestock work, such as calving and lambing, which are happening during Greenhouse season. Plus, as both guys have grown up in ranching families, they thought that working in the greenhouse was for lessor capable residents. They leveraged these two false perspectives to keep themselves out of the greenhouse. Yet, being the instigator that I am, I challenged (with all the staff involved in this) these two men and placed them on crews that were working in the greenhouse. It took a month or so before we stated seeing them respond favorably to their new vocational work, and by the end of the greenhouse season they were doing a great job. So much so that they were telling everyone how important it was for them to be in there and how much they were enjoying it.

One of these guys has always enjoyed irrigating on the ranch and did a respectable job here at SKR. The other one enjoyed raising and tending to a purebred angus herd at home as well as helping with haying. Both guys are very eager workers. Maybe you know who I am talking about. Greg Wennemar and Mike Himes. To Greg, we gave the task of watering hanging baskets (his 6' 7" height was a bonus,) and Mike became very good at helping staff. Specifically he was good at trimming back extra growth on some of our varieties of plants that require it.

When we evaluate the value of our vocational programs, this is one of the successes we love to see, as everyone benefits from someone in our midst improving their skills. When those who improve realize it, they become more confident and can challenge the other residents to try something new. Who knows, maybe they will find something new they really love and are really good at, just because they were challenged to go beyond their false assumptions.

Special K Ranch is a non-profit Christian organization looking for an energetic, loving couple to live with and assist 4 developmentally disabled adults on a working ranch. The ranch has a strong Christian emphasis in philosophy and practice and is looking for like-minded couples. We have 8 familyoriented homes serving 35 adults.

The ranch is located near Columbus, Montana on 220 acres along the Yellowstone River. It offers a living and learning experience in a rural agricultural setting for people with developmental disabilities. Sheep and cattle are raised on the ranch. The residents operate a greenhouse business with bedding plants and hydroponic tomatoes. Special K Ranch is a forever home for our residents; our vision is to nurture the human and spiritual potential of our residents.

Ways to Support Our Mission

Montana Income Tax Credit for Endowed Philanthropy

Important Update! The Montana Legislature has increased the maximum credit to \$15,000 (\$30,000 for couples filing jointly) for Montana taxpayers. Planned gifts, such as charitable gift annuities, qualify for this credit, which is worth 40% of the charitable gift amount. For businesses making an outright gift to a qualifying endowment, the maximum credit has increased to \$15,000. This popular and tax-wise way to give to the SKR Foundation Endowment supports our residents permanently.

Have an IRA?

Individuals who are 70^{1/2} or older can transfer up to \$108,000 from an IRA, directly to a qualifying charity, without recognizing the assets transferred as income. This tax-wise way of giving counts toward meeting the required minimum distribution (RMD) from IRAs. Distributions must be made from the IRA custodian directly to the ranch.

SKR Foundation Endowment

The endowment is the best long-term way to support our residents. This pool of invested funds distributes five percent of its fair market value, annually, to the ranch for general operating and other expenses.

Appreciated stock

Giving appreciated securities yields powerful tax benefits. Generally, the full fair market value can be deducted, and capital gains taxes can be avoided.

Bequest

Including the ranch in your will is a great way to help our residents and leave a legacy. Consider naming Special K Ranch for a percentage, a specific amount, or as the sole benefactor of your estate. Bequests can vastly improve estate tax situations.

How will my gift be used?
