
Mission Statement: Providing family-oriented Christian homes, on a working ranch for adults who have developmental disabilities.

worth a thousand words. I think you will understand what I am trying to convey to you.



Thank you, God, for keeping the flooding Yellowstone River from cutting the ranch in half. In 2015, the Lord gave us a vision and funding to install a levee or dike across an old riverbed channel. This year, when the river kept rising and came over the top of the levee, we experienced flooding

in places that I have never seen at the ranch. Pioneer Park was under two-and-a-half feet of water, and the two ponds became one and looked like a small river. But it was nothing compared to what it would have been if we ignored God's nudging. Long story short, we lost power for a couple of days and our staff rocked getting generators to vital areas of the ranch. A big Thank You to the Beartooth Electric Co-Op and NorthWestern Energy for working 24/7 to get the power back online.

God also provided some much-needed and timely volunteers for the ranch, as well. We were blessed by two groups of interns and their mentors from the CHS Environmental Engineer Team. They cleaned up a couple of big cottonwood trees that we had cut down to prevent them from falling and causing more damage in a storm. They also gathered up and stacked hay bales

from our fields, while another group of them worked in our nursery transplanting and pruning nursery stock. Thank You, CHS, for some much-needed help!

Spring is greenhouse season and life is fast-paced and a little crazy. During that time and shortly thereafter, we added some extras; just to keep us on our toes.

In May, it was determined that the Craig House needed

to be used for our aging and frail residents. This meant moving some residents to make room for the few we knew needed to move. We have a female wing and a male wing now. This started the ball rolling, and when it was all said and done, we moved fifteen residents. Thanks to Marvin and his crew of volunteers, we physically moved everyone in the space of about three-and-ahalf hours one Saturday. He put together crews and an organized chaos that worked very well. All our House Moms helped to pack up in the days prior and then helped residents set up their new spaces. A huge shout out to my House Moms for a task well done! Residents have settled in very well and once again showed me their resiliency!

We had our annual Open House the second Saturday in June; the residents and I wanted to do something a little different. We had FIVE TOP SECRET meetings prior to Open House, and we created an "Employee of the Year" award. The residents were super excited to keep a secret! We discussed qualities of love, patience, working well with others, and most importantly, wanting to teach with love. The residents voted AND kept the secret until the moment of announcement. They also wanted to do more than just a plaque, so they chose to put in their own monies and get a gift card to Scheels. Marvin Schieldt won hands down. The best kept secret ever!!! Once again, residents showed me their patience and love.

The following week, floodwaters arrived, and we lost power and water. We had local residents head home for a few days, staff opened their homes, and some toughed it out as Marvin and his crew (our heroes!) got generators going. Two different power companies worked together and had us up and running within three days. And again, residents showed me their "can do" spirit with love and patience.





Ways to Help and Save on Taxes

Special K Ranch operates independently of government funding.

IRA Charitable Rollover

Individuals who are $70\frac{1}{2}$ or older can transfer up to \$100,000 from an IRA, directly to a qualifying charity, without recognizing the assets transferred as income. This tax-wise way of giving counts toward meeting the required minimum distribution (RMD) from IRAs. Distributions must be made from the IRA custodian directly to the ranch.

SKR Foundation Endowment

The endowment is the best long-term way to support our residents. This pool of invested funds distributes five percent of its fair market value, annually, to the ranch for general operating and other expenses.

Montana Endowment Tax Credit

Montana taxpayers are eligible for a tax **credit** of up to \$10,000 (\$20,000 per couple). Planned gifts, such as charitable gift annuities, qualify for this credit, which is worth 40% of the charitable gift amount. In many cases, a \$10,000 charitable gift annuity can be created for about \$3,500 out-of-pocket, after tax savings.



Appreciated Stock

Giving appreciated securities yields powerful tax benefits. Generally, the full fair market value can be deducted, and capital gains taxes can be avoided.

How will my gift be used?


2022 SKR Fundraising Dinner
